- 1) Nonrefundable deposit of \$ 150.00 at time of reserved date.
- 2) Fifty percent (50 % ) of the remaining balance must be received two weeks prior to arrival date. One week prior to arrival date this deposit becomes non refundable. The amount for this contract is \$ \_\_\_\_\_.
- 3) Use of Bunk House at \$35.00per day per person excluding meals min \$70/night.
- 4) One time fee for set up/ tear down of party tent at \$50.00.

- 7) Any fees generated during the stay will be due prior to departure.

**Rentee agrees to the following terms and conditions**

- 1) Total sleeping capacity in the dorm is 56 people. For co-ed camps the capacity is limited to 28 males and 28 females including all counselors/chaperones.
- 2) Abide by all camp rules and regulations.
- 3) Conduct all activities at camp in accordance with the mission and purpose of Camp Jabez OTC.
- 4) Allow **NO** use of alcohol, tobacco or non prescribed drugs on the camp premises.
- 5) Receive approval for camp fires with the camp facilities manager.
- 6) Assume responsibility for injury to the group's participants, for damage to the property, and structures arising from the group's use of the facilities or activities organized by the above named group.
- 7) Insurance will not be provided by Camp Jabez OTC. **Copy of organization insurance policy is required upon arrival.**
- 8) The Rentee will make good and pay for any damage to the camp (including accidental damage) caused by any act of neglect on the part of the Rentee or those persons permitted at the camp by the Rentee. Under no circumstances will the Camp make good or accept responsibility or liability in respect of any damage, theft, or loss of property, goods, articles or things whatsoever placed, deposited, brought into or left upon the premises by the Rentee or those permitted at the camp by the Rentee for his use or purpose.
- 9) Camp Jabez OTC reserves the right to request any group member or group to leave at anytime if in violation of any of the terms and conditions of this contract.
- 10) The parties agree that any suit arising from this agreement must be brought in courts of Pulaski County, Kentucky

The above release includes the release of Camp Jabez OTC from the consequences of Camp Jabez OTC's own negligence.. The only circumstance under which the release of Camp Jabez OTC does not apply is with respect to any occurrence resulting from the gross negligence or willful misconduct of Camp Jabez OTC. Rentee agrees to indemnify Camp Jabez OTC for any cost incurred in defending any action covered by this release, including a reasonable attorney's fee.
