Rentee agrees to the following terms and conditions

- 1) Nonrefundable deposit of **\$200.00** at time of reservation. This will be taken off the invoice at time of final payment.
- 2) **Final number of people must be received two weeks prior to arrival date. At this time, it becomes non-refundable.** You may add to the numbers at regular price, but this will be the minimum you will be charged.
- 3) **All remaining balance is due upon exit of camp, unless prior arrangements have been made.**
- 4) Total sleeping capacity in the dorm is 64 people. For co-ed camps the capacity is limited to 32 males and 32 females including all counselors/chaperones.
- 5) Abide by all camp rules and regulations.
- 6) Conduct all activities at camp in accordance with the mission and purpose of Camp Jabez OTC.
- 7) Allow **NO** use of alcohol, or non prescribed drugs on the camp premises.
- 8) Receive approval for camp fires with the camp facilities manager.
- 9) Assume responsibility for injury to the group's participants, for damage to the property and structures arising from the group's use of the facilities or activities organized by the above named group.
- 10) Insurance will not be provided by Camp Jabez OTC. **Copy of organization insurance policy is required upon arrival.**
- 11) The Rentee will make good and pay for any damage to the camp (including accidental damage) caused by any act of neglect on the part of the Rentee or those persons permitted at the camp by the Rentee. Under no circumstances will the Camp make good or accept responsibility or liability in respect of any damage, theft, or loss of property, goods, articles or things whatsoever placed, deposited, brought into or left upon the premises by the Rentee or those permitted at the camp by the Rentee for his use or purpose.
- 12) Camp Jabez OTC reserves the right to request any group member or group to leave at anytime if in violation of any of the terms and conditions of this contract.
- 13) The parties agree that any suit arising from this agreement must be brought in courts of Russell County, Kentucky

RELEASE AND FOREVER DISCHARGE: The Rentee does hereby release and forever discharge Camp Jabez OTC components, sponsors, agents, employees, officers, trustees and affiliates of Camp Jabez OTC, of and from any and all liability to the group, the groups assigns, heirs and next of kin, from any and all claims, demands, controversies, action or causes of action, belonging to the above named group now or in the future for any damage to or loss of groups property's, and any injury to groups participants including death or any one or more of the foregoing, arising directly or indirectly out of the group's use of the camp facilities, including any damage, loss or injury caused by any act or omission on the part of Camp Jabez. The above release includes the release of Camp Jabez OTC from the consequences of Camp Jabez OTC's own negligence. The only circumstance under which the release of Camp Jabez OTC does not apply is with respect to any occurrence resulting from the gross negligence or willful misconduct of Camp Jabez OTC. Rentee agrees to indemnify Camp Jabez OTC for any cost incurred in defending any action covered by this release, including a reasonable attorney's fee.
